Hon. Ted Nebbeling, BC Minister of State for Community Charter and 2010 Winter Olympic Bid

Ted Nebbeling was appointed Minister of State for Community Charter in June 2001 and given responsibility for the 2010 Olympic Bid in July. First elected in 1996 to represent West Vancouver-Garibaldi , Mr. Nebbeling has been Opposition critic for municipal affairs, forests, and employment and investment. The Honourable Lawrence MacAulay was appointed Solicitor General of Canada on November 23, 1998. His previous cabinet appointments were Minister of Labour, Secretary of State (Veterans) and Secretary of State (Atlantic Canada Opportunities Agency). He has also served as Associate Critic for Fisheries and Oceans and Official Opposition Critic for Seniors, and chaired the Atlantic Caucus. He was first elected to the House of Commons in 1988 to represent Cardigan in eastern Prince Edward Island. Born in St. Peters Bay, Prince Edward Island, Mr. MacAulay has been a farmer and businessman. He is married with three daughters.

Greg Wright joined the Solicitor General Department in 1998 to work on strategic policy and planning, federal-provincial relations and portfolio coordination. He became Executive Director of the Integrated Justice Information Secretariat in September 2000. His diversified career has included senior positions with Transport Canada and the Canada Customs and Revenue Agency. He was also Chief Information Officer for the Public Service Commission of Canada, responsible for its migration to client/server and then Internet technologies. In 2000, Mr. Wright received a prestigious Gold Medal for Achievement in Leadership for his success in leading his major national initiative on Integrated Justice Information.

Scott Andison has worked in Criminal Justice for 23 years, in the private and public sectors. Formerly Executive Director, Information Technology Services Division, for justice agencies in British Columbia, he holds a Master's degree from U. of Victoria. He has planned, developed and evaluated IT and information management solutions; chaired the province's Advisory Council on Information Management; and sat on the Federal/Provincial board for the Canadian Centre for Justice Statistics, and served on the Federal/Provincial Leadership Committee for the Integrated Justice Initiative. Mr. Andison successfully managed the development and implementation of B.C.'s integrated justice system, JUSTIN, using innovative outsourcing that created a strategic partnership with the systems integrator.

Blake Delgaty joined the Public Service in Ontario in 1977 as a Customs Inspector. After several prairie assignments, he moved to Headquarters in 1980 and concentrated on Customs service to international travellers. Louis Freeh, Former Director, U.S. FBI

Mayor Giuliani called Louis Freeh "the singularly best-suited person in America to run the FBI." As Director 1993-2001, Freeh dramatically changed the bureau as crime became globalized. He more than doubled the number of branches around the world, focused on counterintelligence, cybercrime, DNA technology, electronic surveillance, and built relationships with the private sector to tap its expertise.

Freeh has been an FBI agent, an attorney in landmark cases, and a federal judge. His FBI term was not without controversies, but he had strong support from field agents and fostered unprecedented cooperation with the CIA. Throughout his career, Freeh has been known for his energy, integrity and independence. As FBI Director, he visited 62 countries and met more than 2,000 foreign government leaders.

Freeh is now Senior Vice Chairman, Administration, at MBNA, the world's largest independent credit card lender. He oversees the company's legal affairs and is responsible for personnel, facilities, security and transportation.

Freeh delivers compelling advice for confronting today's complex security and privacy issues, as well as for leading complex operations. He also explains how strategic public/private partnerships can benefit both business and government.

Geoff Plant, Attorney General, Government of BC

Deputy Commissioner Busson joined the RCMP in 1974, serving in British Columbia -- on general duty and as a plainclothes investigator -- while studying Criminology at Simon Fraser University. After graduating from UBC's Faculty of Law, she was transferred to

RCMP Headquarters in Ottawa. She was promoted to Inspector in 1992, serving in Saskatchewan and Vancouver, and to Superintendent in 1996. In 1997 she became Saskatchewan's Chief Superintendent in Charge of Criminal Operations, and in 1998 Commanding Officer, F Division, Saskatchewan. She headed B.C.'s Organized Crime Agency in 1999-2000, then became RCMP Assistant Commissioner commanding E Division. In December 2001, she became Deputy Commissioner, Pacific Region.

Geoff Plant was appointed Attorney General and Minister Responsible for Treaty Negotiations in June, 2001. He previously served in Opposition as critic for the Attorney General Ministry and for intergovernmental relations, and as Caucus Whip. His committee work included Justice, Constitutional Affairs, Intergovernmental Relations and Crime. He was elected in 1996 and re-elected in 2001 to represent Richmond-Steveston. Before his election to the Legislative Assembly, Mr. Plant was a lawyer. He lectured and wrote extensively on aboriginal and education law. Raised in Vancouver, he has a B.A. from Harvard, and law degrees from Dalhousie, Southampton and Cambridge.

David Douglas, Chief Officer of the Organized Crime Agency of British Columbia.

David Douglas joined the Royal Canadian Mounted Police in 1967. He served in provincial policing and drug investigations in Manitoba, rising through the ranks. In 1993 Chief Douglas transferred to Toronto to be Inspector commanding the Combined Forces Special Enforcement Unit. He directed worldwide enforcement projects targeted at major organized crime groups, with investigators from federal, provincial and Toronto-area departments. In 1996 he became commander of the RCMP detachment in London, Ontario. In 1999 he moved to Vancouver as Chief Superintendent and became National Organized Crime Officer for the Pacific Region. In April 2000 Chief Douglas became head of the Organized Crime Agency of British Columbia.

Gwen M. Boniface, Commissioner, Ontario Provincial Police

Since 1997 Gwen Boniface has held progressively responsible positions in the OPP. As Commissioner, she leads more than 7,000 OPP uniformed and civilian members. She earned a B.A. (York) and a B. Laws (Osgoode Hall Law School), and was called to the Ontario Bar in 1990. She was appointed to the Law Commission of Canada in 1997, and has been an adjunct professor at U. of Western Ontario Law School. She has received the Toronto Sun's "Woman on the Move" award and the Order of Ontario, and is a member by invitation of the First Nations Chiefs of Police. In 2001, she became the first female President of the Canadian Association of Chiefs of Police.

Scott Charney, Chief Security Strategist, Microsoft

Scott Charney oversees the development of strategies that enhance the security of Microsoft® products and services. He also collaborates with the computer industry and government to make computing more secure for all users. He leads Microsoft's Security Strategies Group and helps lead Trustworthy Computing, a long-term plan to create secure products, services and infrastructures through the use of appropriate policies and controls, the implementation of best practices, and the development of useable security products and services.

As a principal for PricewaterhouseCoopers prior to joining Microsoft, Charney led the Cybercrime Prevention and Response Practice. Earlier he led the Computer Crime and Intellectual Property Section in the U.S. Department of Justice. As the leading federal prosecutor for computer crimes, he helped prosecute nearly every major hacker case in the U.S. from 1991-99. He co-authored the original Federal Guidelines for Searching and Seizing Computers, the Computer Fraud and Abuse Act, computer crime sentencing guidelines and more. He also chaired the G8 Subgroup on High-Tech Crime and headed the U.S. delegation to an expert group on global cryptography policy for the Organization for Economic Cooperation and Development. He served on the American Bar Association Task Force on Electronic Surveillance, the American Health Lawyers Association Task Force on Security and Electronic Signature Regulations, and the Privacy Working Group of the Clinton administration's Information Infrastructure Task Force.

Charney was an assistant district attorney in Bronx County, N.Y. and ultimately deputy chief of the Investigations Bureau. He supervised 23 prosecutors responsible for arson, racketeering, corruption and economic crimes, and developed a computer tracking system later used city-wide.

Charney's numerous professional awards include the John Marshall Award for Outstanding Legal Achievement (1995) and the Attorney General's Award for Distinguished Service (1998). He was nominated to the Information System Security Association's Hall of Fame in 2000.

Rick McCandless, Assistant Deputy Minister, Court Services, British Columbia

Rick McCandless was appointed Assistant Deputy Minister of the British Columbia Court Services Branch in March, 1998, after four years as Assistant Deputy Minister of Management Services Branch in the Ministry of Attorney General. Rick began his career with the BC Government in 1975, and focuses on strategic planning, financial management and organizational development and integration. He has a Bachelor¹s degree from the University of Victoria and a Masters of Public Administration from Queen¹s University.

Marion Tyson, Q.C., Executive Director, Court Services, Nova Scotia

Ms. Tyson graduated from Dalhousie Law School and joined the Nova Scotia Department of Justice. She became Senior Solicitor in the Civil Litigation Group and appeared at all levels of Court, including the Supreme Court of Canada. She became Director of Legal Services in 1995 and Executive Director of Court Services in 1997. Since 1993, Mr. MacFarlane has been responsible for all of Manitoba's prosecutions, civil litigation, court system and corrections. Previously he had been responsible for all federal prosecutions as Assistant Deputy Attorney General for Canada. In the 80s he was the RCMP's Director of Legal Services and then Alberta Regional Director for the federal Department of Justice. Before that he was a federal prosecutor in Winnipeg. He holds a law degree from U. of Manitoba, and has been called to the bar in Manitoba, Saskatchewan and Alberta.

Hon. Janet Reno, Former Attorney General, U. S. A.

Janet Reno was Attorney General of the United States of America from 1993 to 2001. She graduated from Cornell University and Harvard Law School, and served for 15 years as the State's Attorney for Dade County, Florida. On becoming the United States' first female attorney general in 1993, Ms. Reno headed the world's largest law office (125,000 employees) for nearly eight years, responsible for enforcing federal laws and defending the government in court. During her watch, crime was dramatically reduced and heightened professionalism became the order of the day in the law enforcement community. She was the longest serving attorney general since before the civil war.

Ms. Reno recognized the opportunities for both good and evil in the electronic information revolution of the 1990s. She increased the government's information technology resources devoted to law enforcement. At the same time, she recognized that cyberspace could facilitate globalized criminal activity - and that effective electronic security measures are needed to assure the common international economic good.
